to the Road and Special Road Funds. 2<sup>nd</sup> by Ruppel. Roll call vote; yes; Brown, Ralls

The board reviewed the Sheriff's quarterly report. Ralls moved to enter into an agreement with Hamilton Formerly NCTC for the use of the County ROW. 2<sup>nd</sup> by Ruppel. Roll call vote; yes; Brown, Ralls and Ruppel. Nays; none absent; none not voting; none.

Ralls moved to enter into an agreement with Bobcat for the purchase of a new track loader. 2<sup>nd</sup> by Ruppel. Roll call vote; yes; Brown, Ralls and Ruppel. Nays; none absent; none not voting; none.

Road signs (911 signs) around the county are faded and in need of replacing. There have been many complaints about not being able to read the signs. Sheriff Spanel took some photos of the signs which County Clerk Ruzicka presented to the board. The roadmen will need to make a list of all signs that need to be ordered.

Ronnie Morgan met with the board to discuss the clean-up of the grocery store building. The clean-up is finished, the hole has been filled in and manure spread on top. The village and Ag Society both pledged \$5,000. The Visitor's Committee denied the grant application submitted by the Ag Society. The bill from Jeffres has not come in yet. The county would like to help with the cost once the bill is received. Ralls moved to sign the application for a well permit at the Fire Hall, 2<sup>nd</sup> by Brown. Roll call vote; yes; Brown, Ralls and Ruppel. Nays; none absent; none not voting; none.

Solar Panels are currently being stored in the calf barn and need to be installed. Longhorn electric is willing to install them, they need to come look and the equipment to give a date and estimate.

The Board revied the NPAIT report from the treasurer.

Ralls moved to sign the memorandum of understanding for CSC in order to e-record documents with their company. 2<sup>nd</sup> by Ruppel. Roll call vote; yes; Brown, Ralls and Ruppel. Nays; none absent; none not voting; none.

Caleb Johnson with J13 Enterprises LLC met with the board to discuss taking on the budget for Loup County. Caleb went over his process and knowledge of the budget process extensively, including changes to the process because of recent legislation. Brown moved to enter into a one-year contract with J13 Enterprises LLC to prepare the 2022-2023 budget 2<sup>nd</sup> by Ruppel. Roll call vote; yes; Brown, Ralls and Ruppel. Nays; none absent; none not voting; none.

The Board reviewed the time report.

County Engineer Johnson went over options with the board on bridges that need replaced and which were priority. Bridges discussed were Upstream, Liddy and Porcupine.

There being no further business, the Board adjourned.
